Moorage

New Leases Signed	23

The waitlist has 328 applications on file compared to 346 in the 4th quarter of 2023.

Dry Storage

During the 4th quarter, Dry Storage had a 75% occupancy rate compared to 82.2% in the 4th quarter of 2023. 47 trailers are currently stored at the facility.

Boat Move Activity:

- Total moves by the forklifts for this quarter = 1,108; a 24% decrease
- Launch activity decreased 6%
- Washdown area use decreased 5%

Guest Moorage

The total number of guest moorage boats decreased by 22% (95 fewer boats), and the total number of nights decreased by 20% (129 fewer nights). Most of December, the central guest moorage area was occupied by the Edmonds Yacht Club for the Holiday on the Docks event (10 total vessels, accounting for 300 nights).
